Licence for Playing of Music, Music Videos/DVDs

One copy of this form to be returned by 8 January 2010.

At Slide, there will be a single music system playing throughout the hall, so exhibitors should **not** plan to play music on their stands. It is a legal requirement that you have the relevant licences in place to play any pre-recorded music or music on DVD's or Videos.

The Performing Rights Society (PRS), Phonographic Performance Ltd (PPL) and Video Performance Ltd (VPL) are organisations that represent recording artists, producers and composers of music and DVDs/Videos.

1. PRS Licence - for playing music: licence fee to songwriters, composers, producers.

The cost of a PRS Licence is:

£19.87 + VAT per day (ie £59.61 + VAT for the 3 days of the show)

To obtain a PRS Licence, call freephone 0800 068 4828

2. PPL Licence - for playing music: licence fee to performers.

The cost of a PPL Licence is:

£15.90 + VAT per day (ie £47.70 + VAT for the 3 days of the show)

Return the PPL form overleaf, along with payment and we will apply for a PPL Licence on your behalf. **Enclose a cheque made payable to Rare Management.** A VAT receipt will be supplied to you.

3. VPL Licence - for playing music videos/DVD's

If you plan to play music videos or DVD's, you will need a separate licence for this.
